

Avelo PLUS Spirit Saver\$ Club Status Match Terms and Conditions

Updated May 1, 2026.

1. Introduction

- A. The Avelo PLUS Spirit Saver\$ Club Status Match (as described in more detail herein, the “**Promotion**”) is a limited-time promotional offer made available by Avelo Airlines, Inc. (“Avelo,” “we,” “us” or “our”) that allows eligible Spirit Saver\$ Club members to receive a complimentary twelve (12)-month Avelo PLUS membership.
- B. Your participation in the Promotion is subject to:
 - i. these terms and conditions (these “**Promotion Terms**”); and
 - ii. the [Avelo PLUS Membership Program Terms and Conditions](#) (the “**Program Terms**”), which govern all Avelo PLUS memberships, including memberships obtained through this Promotion.
- C. By submitting a status match request, you acknowledge and agree that these Promotion Terms and the Program Terms are a binding agreement between you and Avelo (collectively, this “**Agreement**”). With that in mind, please review these Promotion Terms and the Program Terms carefully.
- D. In the event of any conflict between these Promotion Terms and the Program Terms, these Promotion Terms shall control with respect to the Promotion. Capitalized terms used herein, but not defined herein, have the meanings provided in the Program Terms.
- E. By submitting a status match request, you acknowledge that you have read our privacy policy.

2. Eligibility

- A. **Spirit Saver\$ Club Membership Required.** This Promotion is open only to active Spirit Saver\$ Club members. To be eligible, applicants must:
 - i. be active members of the Spirit Saver\$ Club at the time of submission; and
 - ii. have joined Spirit Saver\$ Club prior to May 1, 2026.
- B. **Age and Account Requirements.** Applicants must be eighteen (18) years of age or older. Applicants must have, or must create, an Avelo account using the same name and email address provided in their status match request.

- C. **New Members Only.** This Promotion is open to new Avelo PLUS members only. Current and former Avelo PLUS members are not eligible to participate. NO REFUNDS, PARTIAL REFUNDS, CREDITS, OR COMPENSATION OF ANY KIND WILL BE ISSUED TO EXISTING OR FORMER AVELO PLUS MEMBERS IN CONNECTION WITH THIS PROMOTION.
- D. **Limit One Per Person.** Each eligible individual is limited to one (1) status match request and one (1) Avelo PLUS membership obtained through this Promotion.

3. Submission Window

- A. Status match requests must be submitted between May 1, 2026 and May 31, 2026 at 11:59 p.m. Eastern Time.
- B. Submissions received outside of this window will not be accepted.
- C. Avelo reserves the right, in its sole discretion, to modify, extend, suspend, or end this Promotion at any time without notice.

4. Proof of Membership

- A. **Accepted Proof.** Applicants must upload one (1) of the following as proof of active Spirit Saver\$ Club membership:
 - i. a screenshot of their Spirit profile clearly showing Saver\$ Club membership status; or
 - ii. a screenshot from the last 12 months showing your Spirit Saver\$ Club payment confirmation, enrollment, or renewal confirmation email.
- B. **Verification.** Proof must clearly display the applicant's name and active membership status. Avelo reserves the right to request additional documentation to verify eligibility. Submissions with incomplete, illegible, altered, or unverifiable proof will be denied at Avelo's sole discretion.

5. Approval and Activation

- A. **Processing Time.** Eligible status match requests will be reviewed and processed within seven (7) to ten (10) business days of submission.
- B. **Activation.** Upon approval, Avelo PLUS membership will be added to the applicant's Avelo account at no cost.
- C. **Right to Deny.** Avelo reserves the right, in its sole discretion, to deny any status match request for any reason, including without limitation suspected fraud, ineligibility, or failure to provide valid proof of membership.

6. Membership Term and Benefits

- A. **Match Term.** The Avelo PLUS membership obtained through this Promotion is valid for twelve (12) months from the date of approval (the “**Match Term**”).
- B. **Benefits.** During the Match Term, members will receive all standard Avelo PLUS benefits as set forth in the Program Terms, including without limitation exclusive low fares, free priority boarding, special deals, and benefits extending to up to nine (9) companions traveling under the same Reservation.
- C. **Renewal Bonus Excluded.** The fifty dollar (\$50) Avelo Cash renewal bonus described in the Program Terms is not available to members enrolled through this Promotion. Per the Program Terms, the renewal bonus applies only to members who enrolled in Avelo PLUS on or before April 30, 2026.
- D. **No Retroactive Application.** Avelo PLUS benefits cannot be applied retroactively to existing Reservations or to replace ancillary services already paid for. Benefits apply only to new Reservations made after Avelo PLUS membership is active on the member’s account.

7. Renewal

- A. **Automatic Renewal.** Following the Match Term, membership will automatically renew at the then-current annual Avelo PLUS Membership Fee (currently ninety-nine dollars (\$99) per year, subject to change) in accordance with the Program Terms.
- B. **Renewal Notification.** Prior to renewal, members will receive an email notification reminding them to add or update their payment information in their Avelo account profile.
- C. **Opting Out.** To avoid the renewal charge, members must opt out of automatic renewal prior to 11:59 p.m. Eastern Time on the day before their Match Term ends, following the cancellation procedures outlined in the Program Terms.
- D. **Lapsed Payment.** If valid payment information is not on file at the time of renewal, membership benefits may be suspended or terminated at Avelo’s sole discretion.

8. Miscellaneous

- A. **Non-Refundable, Non-Transferable.** Avelo PLUS membership and benefits obtained through this Promotion are non-refundable, non-transferable, and have no cash value.
- B. **No Combining.** This Promotion may not be combined with any other Avelo PLUS offer, discount, or promotion unless expressly authorized by Avelo.

- C. **Email Address Consistency.** Members must use the same email address in their Avelo account as the one provided in their status match request. Email address changes are not permitted, as set forth in the Program Terms.
- D. **Termination.** Avelo reserves the right to terminate, suspend, or revoke any Avelo PLUS membership obtained through this Promotion in accordance with the Program Terms, including in cases of fraud, misuse, or material misrepresentation in the status match request.
- E. **Incorporation of Program Terms.** All other terms, conditions, limitations, and disclaimers set forth in the Program Terms apply in full to memberships obtained through this Promotion.
